## Changes to Survival Craft Equipment Requirements for US Vessels

The Coast Guard has updated type approval requirements for survival craft carried on U.S. flagged vessels. This update removes the requirement for nine pieces of survival craft equipment to have Coast Guard type approval and now requires the manufacturer self-certify that the equipment complies with a consensus standard. These nine types of equipment will no longer have Coast Guard Certificates of Approvals (COAs). This <u>rule</u> goes into effect on 14 December 2022.

The following table shows the nine types of equipment and their new certification and marking requirements.

Certificates of Approval (COAs) for these equipment types are valid until their expiry. COAs are approvals for the manufacturing of equipment and the validity dates correspond to the dates a manufacture is authorized to produce equipment in accordance with the COA. Once a manufacturer's COA expires, they must transition their previous USCG approvals marked "USCG approved" to a new label on the newly produced equipment that shows compliance with the consensus standard.
