

The Golight® Gobee™ 2151 is designed to be used in your existing 2 or 3 prong bow socket. This searchlight with directional flexibility is controlled by a wireless remote, which gives the operator a full 360° horizontal rotation and a 90° vertical tilt with fingertip control.

The Gobee™ Includes:

- Gobee™ Searchlight
- Mounted on 12" stanchion with 12 volt DC Navigation Lights.

INSTALLATION:

EXISTING BOW MOUNT SOCKET

- 1) Determine if your boat has a 2 or 3 prong bow socket.
- 2) 2 Prong: This light has been pre wired to work immediately in 2 prong sockets.
- 3) 3 Prong: Product modification is necessary.
 - A. Detach spotlight from Base by removing 4 screws from bottom of base.
 - B. Locate dark gray wire coming out of stanchion tube that connects with the two black wires in a three point connection.Note: there is also a light gray wire that connects the navigation light to the red and white wires, **DO NOT MODIFY THIS CONNECTION.**
 - C. Remove heat shrink tubing from the two black/dark gray 3 point connection
 - D. Disconnect dark grey wire (with male blade) from 3 point connection.
 - E. Locate black wire with male end coming out of stanchion tube and plug in to female connection where the dark gray wire was connected.

- F. Wrap connection with electrical tape or replace with new heat shrink tubing to ensure connection and prevent shorting out.
- G. Wind dark grey wire around stanchion pole
- H. The proper connection will now have three black wires connected and the dark grey wire disconnected.
- I. Re-assemble spotlight back to the base.

4) Carefully engage stanchion into base socket. As it slides into socket, make sure the alignment screw at rear of stanchion slides into notch at rear of socket. Push stanchion down until it engages with electrical connector at bottom of socket. Lock unit in place by sliding lock collar into the top of the socket and rotate clockwise. Check to make sure stanchion is secure in the socket .
The Gobee™ is now ready for use.

BULB REPLACEMENT

The Golight® Gobee™ utilizes a H-3 55 watt bulb, which may be purchased through Golight™ Inc.— 308-278-3131 or 800-557-0098.

TROUBLESHOOTING YOUR GOBEE™

Power requirements: This product requires a minimum voltage of 12V and requires at least 5.5—6 amps to function. 7 amp fuse recommended. If the power receptacle is wired correctly and the light will still not activate with the remote, the boat wire may not be the recommended gauge. Golight Inc. recommends a minimum of 14 gauge wire; 16 gauge may or may not be sufficient depending on the total length of wire.

PROGRAMMABLE REMOTE INSTRUCTIONS

The Golight® Gobee™ is controlled with a programmable remote with 16 different channels. This feature allows you the freedom to change the channel selection, and the receiver relearns the new selection.

PROGRAMMING THE TRANSMITTER

This light has been pre-programmed at the factory, and it is not necessary to re-program the transmitter, unless you experience outside interference.

1. **IMPORTANT:** Remove from base socket.
2. Remove battery cover from remote control
3. Set the 4 dip switches to a selection of your choice. There are 2 positions on each; use a small screwdriver and select a position for each dip switch.
4. Replace battery cover
5. Depress the on/off button and keep it held down.
6. While holding the on/off button down, reinstall the power to the unit (replace Gobee™ into base socket)
7. Keep your finger on the on/off button for 5-6 seconds, and then release. The light should now be reprogrammed.

OPERATION OF GOLIGHT® GOBEE™

1. Using the remote control, turn on the light by depressing the on/off button.
2. With the 4 way arrows on the remote control, rotate your light to the desired location. Depending on the conditions, the wireless remote may be used up to 15 feet from the Gobee™.
